The Consumer Product Safety Commission estimated that over 10,000 UTV accidents resulted in fatalities or emergency room visits in 2021. With UTV's becoming more prevalent in the workplace, this seminar will discuss common safety hazards, applicable laws for the State of Iowa, and how you should manage UTV safety in your workplace.

Suicide Prevention in Construction

Diane Rohlman, PhD - Associate Dean for Research, Professor and Endowed Chair in Rural Safety and Health, University of Iowa

Construction is one of the most hazardous industries, with high rates of fatal and non-fatal injuries. Work organizational factors such as irregular employment, lengthy commute times, long work hours, and employer policies all impact health and safety. Construction workers also have higher rates of alcohol use, smoking, and engage in other unhealthy behaviors. In addition, suicide rates in the construction industry are the second highest among all occupations. Behavioral health problems can lead to increased absenteeism, high turnover, lost productivity, and workplace injuries. Characterized by a "tough guy" culture, stigma can prevent individuals from seeking treatment. A leadership commitment to health and safety, workplace policies, and supervisor training can promote worker well-being on the construction site.

Workers' Compensation Legal Update: Where are we now?

Practical Strategies for Reducing Recordable Injuries Coral AB

She covers some examples used in the training, such as a shaving cream demonstration, activities to highlight respirator fit and care, UV light applications for sun safety, use of virtual reality/360 video, and tips on engaging young adults through social media.
